

**IN THE MATTER** of the Sale and Supply of Alcohol Act 2012

**AND**

**IN THE MATTER** of an application by The Taupo Aero Club Incorporated for a new Club Licence pursuant to Section 100 of the Act in respect of the premises situated at **1075 Anzac Memorial Drive (Private), Taupo**, and known as "The Taupo Aero Club"

**The Application:**

This is an application by **The Taupo Aero Club Incorporated** for a new Club Licence in respect of premises situated at **1075 Anzac Memorial Drive (Private), Taupo** and known as **The Taupo Aero Club**. It was formally received by the Taupō District Licensing Committee on 22nd August 2019. The general nature of the business to be undertaken is that of **Sports Club**.

The application was duly advertised in the Taupo Times newspaper on 30 August 2019 & 6 September 2019 and no objection or notice of desire to be heard has been received. Display of the public notice has been carried out in the terms of the Sale and Supply of Alcohol Act 2012 by the licensee and no objections were lodged by any members of the public.

**Reasons for the Decision:**

The Aero Club has responded to the indication from the DLC that a Club Licence would be the most appropriate licensing regime for the activities at the Clubrooms.

The Club now seeks a Club Licence and has two certificated managers appointed to the Club. A certificated manager, or other properly appointed Acting or temporary manager will be on duty whenever the Club bar is open.

Alcohol and the safe flying airplanes is very much a 'no go' area and the Club appears to accept its responsibilities and be a responsible entity and can be granted a licence.

The Police and Medical Officer of Health reports raise no matters in opposition.

**The Decision:**

We are satisfied as to the matters to which we must have regard as set out in Sections 105 & 106 of the Act and we grant the applicant a Club Licence pursuant to Section 21.

The applicant's attention is drawn to Sections 5 & 214(3) of the Act obliging the holder of a club licence to display:

1. A copy of the licence, and of the conditions of the licence, attached to the interior of the premises so as to be easily read by persons entering through each principal entrance.
2. A sign prominently displayed inside the premises, which identifies by name the manager for the time being on duty.

**CLUB LICENCE**

Sections 21 and 64, Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012 **THE TAUPO AERO CLUB INCORPORATED** is authorised to sell and supply alcohol, on the premises situated at **1075 Anzac Memorial Drive (Private), Taupo** and known as **The Taupo Aero Club**, for consumption on the premises, to any person who-

- a) is a member of the club; or**
- b) is on the premises at the invitation of, and is accompanied by, a member of the club; or**
- c) is a member of some other club with which the club has an arrangement for reciprocal visiting rights for members; or**
- d) is on the premises at the invitation of an authorised visitor who is also on the premises.**

The authority conferred by this licence shall be exercised through a manager or managers appointed by the club in accordance with Sub-Part 7 of Part 2 of the Act.

**CONDITIONS**

This licence is subject to the following conditions:

1. Alcohol may be sold or supplied for consumption on the premises only on the following days and hours: **Monday to Thursday from 4.00pm to 9.00pm; Friday from 2.00pm to 11.00pm; & Saturday and Sunday from 12.00 noon to 11.00pm.**
2. Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises.
3. The Licensee must have available for consumption on the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages.
4. Food must be available for consumption on the premises at all times the premises are open for the sale and supply of alcohol, in accordance with the sample menu supplied with the application for this licence or menu variations of a similar range and standard. Menus must be visible, and food should be actively promoted.
5. A properly appointed certificated or Acting or Temporary Manager must be on duty at all times when the premises are open for the sale and supply of alcohol, and their full name must be on a sign prominently displayed in the premises.
6. The Licensee must provide information, advice and assistance about alternative forms of transport available to patrons from the licensed premises.
7. Whilst the premises are open for the sale and supply of alcohol no BYO alcohol may be consumed on the premises.
8. The Club must display:
  - a. At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons,
  - b. A copy of the licence attached to the premises so as to be easily read so as to be easily read by persons using the premises.

**THE LICENSED PREMISES**

The sale, supply or consumption of alcohol is authorised in the premises generally including the outdoor areas. The premises situated at 1075 Anzac Memorial Drive, Taupo, are more precisely identified as outlined in a plan date stamped as received by the Taupo District Licensing Committee on 22 August 2019.

**DISPLAY OF LICENCE AND PRINCIPAL ENTRANCE**

A copy of this licence must be displayed at the principal entrance to the premises. The entrance from Anzac Memorial Drive is designated as the principal entrance.

**DURATION**

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force -

- (a) Until the close of the period of 1 year commencing with the date of its issue; or
- (b) If an application for the renewal of the licence is duly made, until the application is determined; or
- (c) If the licence is renewed, until the close of the period of 3 years after the period for which it was renewed.

**This licence expires on 30 September 2020 unless further renewed**
