

IN THE MATTER of the Sale and Supply of Alcohol Act 2012 (the Act)

AND

IN THE MATTER of an application by Sail Tiua Limited for a new ON licence (for Conveyance) pursuant to Section 100 of the Sale and Supply of Alcohol Act 2012 in respect of the premises situated at **Berth 16/17, Taupo Boat Harbour, Redoubt Street, Taupo** and known as "Sail Tiua"

The Application:

This is an application by Sail Tiua Limited for an On Licence for Conveyance in respect of vessel based at Berth 16/17, Taupo Boat Harbour, Redoubt Street, Taupo and journeying on Lake Taupo, known as "Sail Tiua". It was formally received by the Taupō District Licensing Committee on 23rd June 2023. The general nature of the business to be undertaken is that of Conveyance.

The application was duly advertised in the Taupo & Turangi Herald newspaper on the 29th of June and 6 July 2023 and no objection or notice of desire to be heard has been received. Display of the public notice has been carried out in the terms of the Sale and Supply of Alcohol Act 2012 by the licensee and no objections were lodged by any members of the public.

The Reasons for the Decision:

The applicant appears to be a suitable entity to hold an ON licence and a certificated manager will oversee the sale, supply and consumption of alcohol.

The Police and Medical Officer of Health reports raise no matters in opposition.

The Decision:

We are satisfied as to the matters to which we must have regard as set out in the Act and we grant the applicant an On Licence authorising the sale and supply of alcohol for consumption on the conveyance, to any person present on the vessel and to allow the consumption of liquor on the conveyance by any such person.

The licence shall be subjected to specific conditions as detailed in the attached licence.

ON-LICENCE

(for Conveyance)

Sections 14 to 16 and 64 of the Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012, **SAIL TIUA LIMITED** is authorised to sell and supply alcohol, on the vessel known as "**Sail Tiua**" based at Berth 16/17, Taupo Boat Harbour, Redoubt Street, Taupo, and journeying on Lake Taupo, to any person present on the vessel and to allow the consumption of alcohol on the conveyance by any such person.

CONDITIONS

This licence is subject to the following conditions:

1. Alcohol may be sold or supplied for consumption on the vessel only on the following days and hours during the period of any scheduled cruise: **Monday to Sunday from 9.30am to 10.30pm**
2. No alcohol is to be sold or supplied on the vessel on Good Friday, Easter Sunday, Christmas Day or before 1.00pm on Anzac Day to any person other than a person who is on the premises to dine.
3. Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the vessel.
4. The Licensee must have available for consumption on the vessel, at all times when the vessel is open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages.
5. **Food must be available for consumption on the vessel at all times the vessel is open for the sale and supply of alcohol, in accordance with the sample menu supplied with the application for this licence or menu variations of a similar range and standard. Menus must be visible and food should be actively promoted.**
6. A properly appointed certificated or Acting or Temporary Manager must be on duty at all times when the vessel is open for the sale and supply of alcohol, and their full name must be on a sign prominently displayed in the vessel.
7. The Licensee must provide information, advice and assistance about alternative forms of transport available to patrons from the vessel.
8. The Licensee must display:
 - a. At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons;
 - b. At the principal entrance to the premises, so as to be easily read by people immediately outside the premises, a sign stating the ordinary hours of business during which the premises will be open for sale of alcohol,
 - c. A copy of the licence attached to the vessel so as to be easily read by patrons

THE LICENSED PREMISES

The sale, supply or consumption of alcohol is authorised on the vessel generally. The premises based at Berth 16/17, Taupo Boat Harbour, Redoubt Street, Taupo, are more precisely identified as outlined in a plan date stamped as received by the Taupo District Licensing Committee on 21 June 2023.

DISPLAY OF LICENCE AND PRINCIPAL ENTRANCES

A copy of this licence must be displayed in a prominent position in the conveyance.

DURATION

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force -

- a) Until the close of the period of 1 year commencing with the date of its issue; or
- b) If an application for the renewal of the licence is duly made, until the application is determined; or
- c) If the licence is renewed, until the close of the period of 3 years after the period for which it was renewed.

This licence expires on 7 August 2024 unless further renewed
