DECISION OF THE TAUPŌ DISTRICT LICENSING COMMITTEE

Before the Taupō District Licensing Committee:

The Application:

This is an application by Janine Poultney for the renewal of a Managers Certificate pursuant to Section 224 of the Sale and Supply of Alcohol Act 2012. It was formally received by the Taupō District Licensing Committee on 5th October 2023.

Reasons for the Decision

1. The applicant holds the Licence Controller Qualification and is employed in licensed premises.
2. The Licensing Inspector has provided a report outlining the applicant's experience in controlling licensed premises and has tested their understanding of their responsibilities as a Manager.
3. Neither the New Zealand Police nor the Licensing Inspector express any concerns about the suitability of the applicant, nor do they oppose the renewal of the certificate.
4. **We note the warning given after the incident at the Taupo Races recently. Licensees and managers must ensure that they preserve their suitability to continue to hold licences and certificates. The above incident does not reflect well on the applicant. We do not expect any similar repeat offending.**
5. Subject to the above, the application can be dealt with on the papers.
6. The application and supporting information satisfies the Committee that the criteria we must have regard to as set out in Section 227 of the Act have been met.

Decision of the Taupō District Licensing Committee:

The District Licensing Committee Commissioner, acting pursuant to the Sale and Supply of Alcohol Act 2012 approves the application by Janine Poultney for the renewal of a Manager's Certificate.

The certificate is renewed for a further period of three years from the date of expiry of the current certificate.
