

IN THE MATTER of the Sale and Supply of Alcohol Act 2012

AND

IN THE MATTER of an application by J & H Enterprises 2018 Limited for the renewal of a licence pursuant to Section 127 of the Act in respect of the premises situated at **161 Taharepa Road, Taupo** and known as "**Super Liquor Tauhara**".

THE APPLICATION

This is an application by **J & H Enterprises 2018 Limited** for the renewal of an **Off Licence** in respect of the Licensed Premises known as **Super Liquor Tauhara**, situated at **161 Taharepa Road, Taupo**.

The applicant is the holder of an **Off Licence** 20/OFF/0093/2018 which was first granted by the Taupō District Licensing Committee on 17th September 2018.

The application was duly advertised on the Taupo District Council website from 24 July 2019 for a period of 10 days and no objection or notice of desire to be heard has been received. Display of the public notice has been carried out in the terms of the Sale and Supply of Alcohol Act 2012 by the licensee and no objections were lodged by any members of the public.

The Inspector has provided a comprehensive report that outlines the safe and responsible operation of this licence for many years.

REASONS FOR THE DECISION

The applicant is a proven operator and has not come to notice in an adverse manner for any of the reporting agencies. The hours are reasonable, and the host responsibility practices appear sound.

The additional discretionary conditions imposed by consent at the time of granting the licence will continue.

THE DECISION

I direct that a notice of renewal and a replacement licence be issued.

Notice of Renewal of Off Licence

The Off Licence in respect of the premises situated at 161 Taharepa Road, Taupo known as “**Super Liquor Tauhara**” is renewed.

The present conditions of the licence shall continue to apply.

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licenses, the licence continues in force—
