IN THE MATTER of the Sale and Supply of Alcohol Act 2012 (the Act)

AND

IN THE MATTER of an application by FWD Limited for the renewal and variation of an ON licence pursuant to Section 127 of the Sale and Supply of Alcohol Act 2012 in respect of the premises situated at 56 The Town Centre, Turangi and known as “**RUST**”

BEFORE THE TAUPŌ DISTRICT LICENSING COMMITTEE:

The Application:

This is an application by FWD Limited for the renewal and variation of an **On Licence** in respect of the licensed premises known as **RUST**, situated at **56 The Town Centre, Turangi**. It was formally received by the Taupō District Licensing Committee on 15th November 2018.

The applicant is the holder of an **On Licence** 20/ON/0274/2017 that was first issued by the Taupō District Licensing Committee on 16 November 2017.

The application was publicly notified in the Turangi & Taupo Weekender newspaper on 13 December 2018 and on 20 December 2018. There was also a notice placed on the exterior of the premises during this time.

The applicants seek to increase the hours of operation from 11am to 11pm to 8am to 1am the following day. They also seek to enlarge the licensed premises footprint in the outdoor area. There are no planning issues, but the application drew an objection from a nearby neighbour.

The objector alleged that there was “constant movement” and that the premises can get “quite noisy.”

The Reasons for the Decision:

Such allegations are often indicators of a problem premises. **The** Inspector has discussed the allegations with the objector and her support person. In an email dated 8 March 2019 the objector has declined an opportunity to give evidence at a hearing.

The Inspector has provided a comprehensive report that outlines the safe and responsible operation of this licence for many years. We are told that the premises largely operate as a restaurant during the day and early in the evening.

The applicant is a proven operator and has not come to notice in an adverse manner for any of the reporting agencies. The hours sought are reasonable and the host responsibility practices appear sound.

As the objector does not require a hearing, I consider the application on the papers.

The Decision:

We remind the applicant that the additional hours and licensed area are to be respected and that they do have residential neighbours nearby.

Overall, we are satisfied as to the matters to which we must have regard as set out in the Act and approve the renewal of the licence for 3 years on the amended conditions as set out on the attached replacement licence.

The outdoor area must be clearly defined with picket fencing or similar. Noise from patrons and the business activity are to be closely monitored and controlled to ensure no unreasonable noise nuisance is created for neighbours.

Notice of Renewal and Variation of On Licence

Section 135, Sale and Supply of Alcohol Act 2012

To: **FWD Limited**

Licence **20/ON/0274/2018** replacing licence **20/ON/0274/2017**

The On Licence in respect of the premises situated at 56 The Town Centre, Turangi known as “**RUST**” is renewed and varied.

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licenses, the licence continues in force—

- until the close of the period for which it is renewed; or
- if an application for the renewal of the licence is duly made before it would otherwise expire, until the close of the period of 3 years after the period for which it is renewed.

The licence is renewed for three years and expires on 20 December 2021.
